Dear Kane

The Parish Council considered the plans for the improvements to Wellington Street and had a number of comments to make.

I have set out below the comments from the minutes

### RESOLVED

- a) that the road priority should be given from Wellington Street into Milford Road and not from Manchester Road;

The proposed priority reflects the relative weight of the traffic flows entering the junction. It would be useful to have some more detail on the reasoning for this viewpoint from the PC.

- b) that more robust and hard-wearing materials should be chosen;

Does the PC mean more robust and hard-wearing compared to what is currently in place (in which case I agree, and I think we have identified more robust materials), or do they mean more robust and hard-wearing compared to what we are proposing (in which case I disagree?).

- c) that there should be some form of railway feature included in the design to recognise the location;

Could some form of railway track feature be incorporated through the patterns of the different coloured blocks?

- d) that further plans need to be drawn up to include these suggestions.

Further plans will be drawn up as part of the response to the consultation feedback. There will not necessarily be another round of consultation, although we could look at meeting with Parish Council reps to discuss their points.
